A Message from the Fire Marshal of Ontario

As the new Fire Marshal of Ontario, I am pleased to present the 2020-2021 Ontario Fire College (OFC) Course Calendar. I am excited to share several announcements and new initiatives for the upcoming academic year with you.

The 2020-2021 Calendar provides an increase in course offerings for the first two lines of defence, an expansion of blended course delivery, and better access to courses thanks to our partnerships with over 15 Regional Training Centres (RTCs). We are also diversifying course offerings with the recent launch of the Professional Chainsaw Operation in the Fire Service course, the Ministry of Transportation Ontario Fire Service Driver Trainer Certification program, and the specialized Fire Dynamics course. In 2020, the OFC will also reintroduce Technical Rescuer courses under the NFPA 1006, 2017 Edition, starting with Ice Rescue at the Awareness level.

We are adopting a new delivery format for the NFPA 1002 Pump Operations course. The course has been revised to incorporate both online and in-class training, using a blended delivery model and meets the NFPA 1002, 2017 Edition. A complete reworking of the old NFPA 472 program for Hazardous Materials has also taken place with the College's move to the NFPA 1072 program. Our OFC team will continue to update our courses to recognize new editions of the NFPA professional qualifications standards throughout the year.

We are continuing to develop and support RTCs across the province, including our most recent additions in Innisfil, Grey Highlands, and Mississippi Mills. As we work to expand our learning contracts to deliver training to fire departments, the OFC will also be recruiting for new adjunct instructors in the coming year.

A new Fire Marshal Executive Officer Leadership series will be offered in 2020. In partnership with the Ontario Municipal Management Institute (OMMI), we will introduce a Fire Marshal enhancement to the Certified Municipal Manager (CMM) program. This program will complement the NFPA 1021 Fire Officer programs, through a partnership with the National Fire Academy. The enhancement is intended to enrich managerial and leadership skills for officers and aspiring officers.

In an effort to support firefighter training for French-speaking fire departments or personnel across the province, we are working with l'École nationale de pompiers du Québec. Programs being discussed for development include NFPA 1001 level I and level II, NFPA 1072 Awareness and Operations levels, Fire Fighter Survival, and NFPA 1002 Pump Operations.

I look forward to another exciting year and hope that you take advantage of the professional growth opportunities with the OFC.

How to Register for Courses at the OFC

To be eligible to apply for an OFC course, the applicant must be an active member of a municipal fire department in the province of Ontario, either as a career, part-time, or volunteer firefighter.

With the exception of specialty courses, e-applications are processed in the order that they arrive at the Office of the Registrar. To increase your chances of being accepted on courses, e-applications should be sent in as soon as possible.

Once courses have been filled, students are accepted onto a waitlist. If cancellations come in throughout the year, the fire chief or designate of the next candidate on the waitlist will be notified immediately.

Please note that courses fill up fast and have significant waitlists, you are encouraged to apply for these courses as quickly as possible.

Submission Day: Applications can be submitted beginning **Monday, July 29, 2019.**

Preparing All Applications for Your Fire Department in Advance of Submission Day:

Fire departments can prepare all the applications they will require prior to submission day by completing and saving a copy of each application form. Open the application form, complete the form, save a copy identifying student surname and course, and **on the submission day noted above**, attach a **maximum of ten applications** into an email and send it to applyofc@ontario.ca; repeat as necessary. It is best not to exceed the maximum number of ten applications per email to ensure your email will be received.

Ensure the applications are signed. Applications without the signature of the fire chief or designate will be declined.

Applications can be submitted in the following formats:

1) Electronically Submit Online

Open the application form, complete the form and click on the **submit** button on the top right corner of the application form. Before you exit to prepare another application, remember to save a copy of each application you submit. The application will be automatically sent to the applyofc@ontario.ca email address at the Office of the Registrar.

We encourage you to apply for courses using the **electronic application form**.

2) Print, Scan and Email:

Print, complete, and scan the applications (signed by the fire chief or designate) and send by email to applyofc@ontario.ca. Should you choose to scan and email please include **no more than ten applications per attachment**.

3) Fax

If you have no other alternative, please fax your applications to **705-687-4611**.

Please note that we no longer accept hand-delivered applications.

Maximum Number of Applications Approved per Course, per Fire Department:

In order to accommodate as many fire departments as possible on each course, a maximum of two applications per fire department per course delivery date will be accepted unless otherwise noted.

How to Improve Your Fire Department Personnel's Chances of Being Accepted on Courses:

- Fill out the E-application form completely showing course numbers and start date
- If you are scanning the application form to submit by email, please print legibly
- Make sure the application is approved by the fire chief or designate
- Complete a separate e-application form for each participant for each course

When applying for a series of courses where prerequisites apply, the participant must be accepted on the prerequisite course before they can be accepted on the remaining courses. In other words, if the course applied for is full, and the student is placed on the waitlist, the e-application for the following course will be rejected and you must re-apply when the prerequisite is met.

If there is documentation required, for example, copies of licences, certificates, etc., ensure that the fire chief or designate have attested to the fact that the student has the required documentation by signing the e-application form. Random audits will be done throughout the year to ensure that documentation is available at the fire department.

Receiving OFC Records of Completion & Academic Standards and Evaluation (AS&E) Certificates with Seals

OFC Student Course Results and Records of Completion / Attendance Certificates

A student grade report and record of completion certificate will be issued and sent by mail to the attention of the fire chief at the fire department upon successful completion of all courses. The OFC record of completion provides proof for the **training portion of the course only**. It does not convey or confer certification to NFPA professional qualification standards as this can only be achieved by satisfactory completion of the knowledge and practical skills testing administered by the Academic Standards and Evaluation (AS&E) Unit of the Office of the Fire Marshal and Emergency Management as described below.

For seminars and workshops, records of attendance certificates will be issued and sent by mail to the attention of the fire chief at the fire department.

NFPA Exam and Practical Skills Testing Results Including Certificates with Seals

All provincial certification evaluations, including knowledge and practical skills tests for NFPA professional qualification standards, are issued by AS&E from the Office of the Fire Marshal and Emergency Management in Toronto. They are sent by mail to the attention of the fire chief at the fire department. Certificates with IFSAC seals are issued and sent once the student has met all of the prerequisite requirements and has successfully completed the exam and practical skills testing for NFPA standards, where applicable.

Enrolment and Registration Guide

Disability-Related Accommodations

If you require a disability-related accommodation to participate in a course or seminar at the OFC, please contact the Office of the Registrar at applyofc@ontario.ca to provide a request and contact information.

Students with Learning Disabilities – Assistance with Written and Practical Exams

If a student requires assistance in writing an exam or completing the requirements of practical skills testing as a result of a learning disability the fire chief or designate must notify the Office of the Registrar in writing at applyofc@ontario.ca as soon as the student is registered and approved to attend the course so that arrangements can be made with AS&E.

Transcripts and Training Records

OFC training records provide information for courses; seminars and workshops attended **at the OFC only**. They do not include certification records. There are three options available to obtain training records:

1. List of Courses Successfully Completed

On request, a list of successfully completed courses will be released to a student for employment applications, to supplement requests for course equivalency at other educational institutions, and to provide a comprehensive list of completed courses when training records have been merged from multiple fire departments into one.

These lists are not intended for an individual to request continually to track their progress. Student grade reports and records of completion certificates are provided for this purpose, and it is the responsibility of each student to maintain their own records. This list does not include grades.

Please send the request by email to applyofc@ontario.ca providing the name of all fire departments employed with past and present. The list will be returned by email.

2. Official Transcript

An official transcript includes a list of all courses attempted with grades obtained, seminars and workshops that have been attended, and identifies any diplomas received, if applicable. An official transcript is printed on parchment; it is embossed with the OFC seal and is authorized by the Office of the Registrar.

Students must send the written request with the administrative fee of **\$10.00** (per copy) payable by cheque or money order to the **Minister of Finance**. We **do not** accept credit card payments.

In the written request, please include an email address, a phone number, and an exhaustive list of all fire departments you have been employed with. Please be sure to include a return address as the transcript must be sent out by mail.

3. Fire Department Training Records (Restricted to Fire Chiefs or Their Designates)

A fire chief or designate can request a list of courses successfully completed by members of their fire department semi-annually, spring and fall, by sending the request by email to applyofc@ontario.ca.

A list of courses successfully completed by members of their fire department will be returned by email. This list does not include student grades. This list will assist in identifying the progression of students through programs, it is not intended as a replacement for the fire departments own training records.

Blended Learning: An Introduction

What is Blended Learning?

In an attempt to be more accessible, attainable, and affordable to the Ontario fire service, the OFC has expanded its delivery models to include blended learning. Blended learning is the integration of traditional face-to-face classroom instruction with online learning, where technology is used to enhance learning and teaching activities. At the OFC, blended learning takes the form of online access to course materials that students use for self-directed, asynchronous, learning before attending in-class sessions.

What is Required of Students?

When students are registered in a blended course, their fire chief or designate is instructed to provide the course coordinator with an email address for the student. The course coordinator will use this contact information to provide instructions for accessing online course materials.

The commitment to enrolling in a blended course is twofold; students must first complete an online self-directed program within a specific timeframe. Generally speaking, the online portion of a blended course begins before the start date of the in-class sessions; pre-class documents provide specific details for each course's parameters and progress through the pre-class material is monitored by the course instructor. The student **must complete the online coursework prior** to the commencement of the in-class sessions to attend and progress through the course.

Students that arrive unprepared or do not bring the required items will not be eligible to attend.

Vacancies

Vacancy applications will no longer be accepted for courses or workshops. Applicant names are required, no spaces will be held.

Cancellation Policy

The fire chief or designate should notify the Office of the Registrar in writing by email at applyofc@ontario.ca as soon as you realize that your candidate will not be able to attend. **We do not accept verbal cancellations.**

If you wish to send a substitute student, submit an e-application form with a note regarding the replacement before the student attends the OFC. Please ensure that any substitute student has successfully completed the prerequisite requirements, if applicable, and that they have been given adequate time to complete pre-class materials.

For cancellations received **less than eight weeks before the start date** of the course or workshop, the registration fee will still apply and be invoiced to the fire department.

Legislation

This course offers students an overview of the various laws, regulations and standards that impact the delivery of fire protection in Ontario. The NFPA professional qualification standards and Section 21 Guidance Notes are discussed, along with the Fire Protection and Prevention Act, 1997, Occupational Health and Safety Act, and other legislation that affect day-to-day fire service operations. This course is offered online and regionally throughout the province. There is no restriction on the number of students per fire department that can register for this course.

Students must commence the course on the start date, and they have sixty days from the start date to complete the course, or they will not be successful.

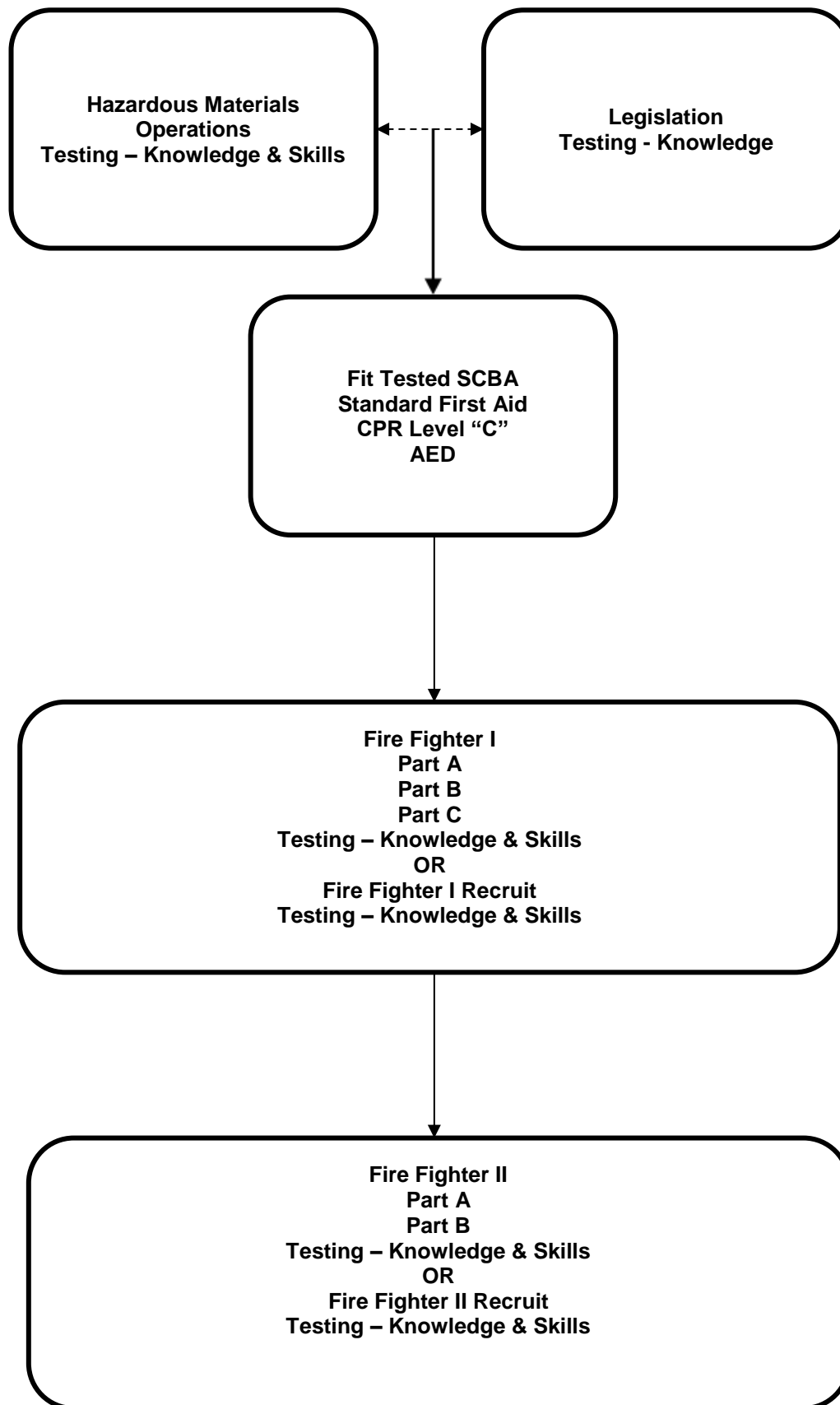

NFPA 1001 Fire Fighter I Programs

The Fire Fighter I programs meet the knowledge and skill requisites established by the NFPA 1001 Standard for Fire Fighter Professional Qualifications, 2013 Edition.

The Fire Fighter I program is divided into three separate courses, Part A, B, and C. Each course builds on the previous part and cumulatively prepares students to meet all the requirements of NFPA 1001 Chapter 5, 2013 Edition.

The Fire Fighter I Recruit program is one course divided into three sessions as part of a blended course delivery format. The student will participate in a classroom-based session, a self-directed online session, as well as a practicum. Each session builds on the previous one and cumulatively prepares students to meet all the requirements of NFPA 1001 Chapter 5, 2013 Edition.

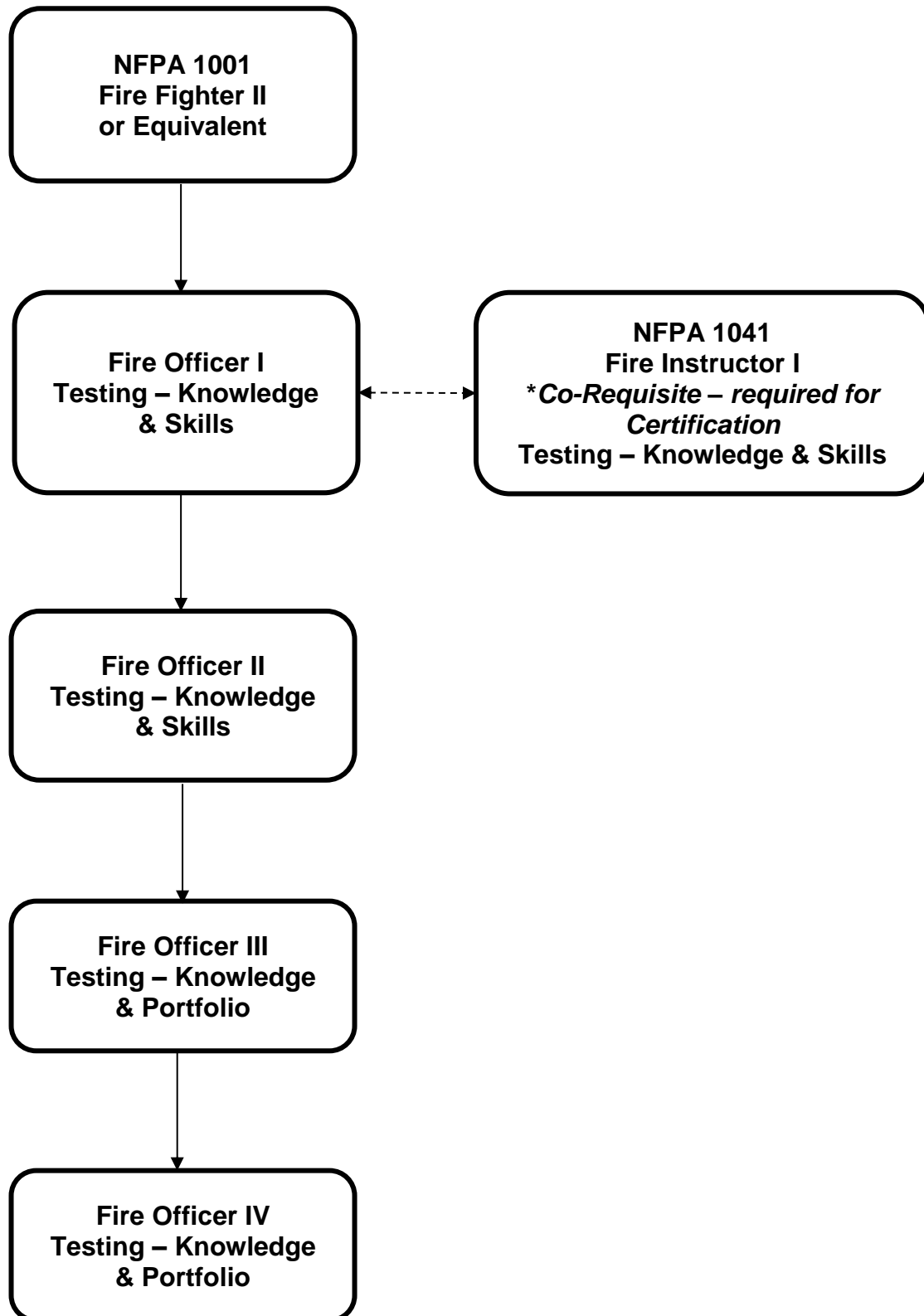

NFPA 1021 Fire Officer Program

The Fire Officer program meets the knowledge and skill requisites established by the NFPA 1021 Standard for Fire Officer Professional Qualifications, 2014 Edition.

The Fire Officer program offers a mix of classroom-based sessions, online self-directed learning, as well as practicums. Each level builds on the previous one and cumulatively prepares students to meet all the requirements of NFPA 1021, 2014 Edition.

Provincial testing through AS&E with the Office of the Fire Marshal and Emergency Management will be conducted at the conclusion of the Fire Officer I and II courses. Students must also complete and submit their skills sign-offs to receive certification.

For Fire Officer III and IV, provincial testing is project based.

NFPA 1021 Fire Officer I

This course provides students with timely information that aids in their daily performance as a fire officer. Topics covered include roles and responsibilities, administration, accountability, cultural diversity, health and safety, human resource management, public relations, functional leadership, incident command, inspection and investigation, budgeting process, basic strategic planning, and basic strategy and tactics. The Fire Officer I course is intended for the frontline fire officers with a supervisory role.

NFPA 1031 Fire Inspector Programs

The Fire Inspector programs meet the knowledge and skill requisites established by NFPA 1031 Standard for Professional Qualifications for Fire Inspector and Plans Examiner, 2014 Edition.

NFPA 1041 Fire Instructor Program

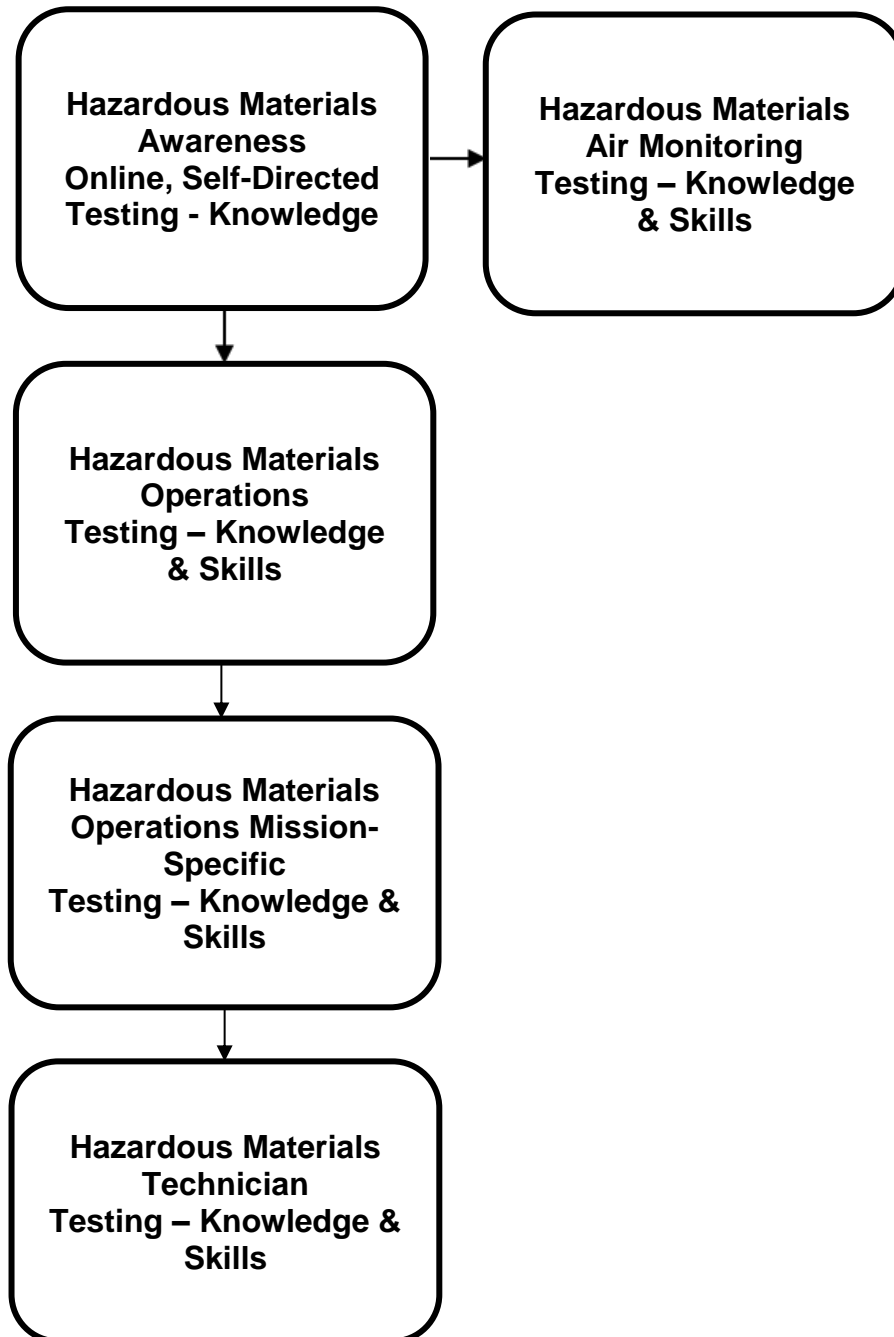

NFPA 1072 Hazardous Materials Program

The Hazardous Materials program meets the knowledge and skill requisites established by the NFPA 1072 Standard for Competence of Responders to Hazardous Materials Incidents Professional Qualifications, 2017 Edition.

The Hazardous Materials program offers a mix of classroom-based sessions, online self-directed learning, as well as practicums. Each level builds on the previous one and cumulatively prepares the student to meet all the requirements of NFPA 1072, 2017 Edition.

Provincial testing through AS&E with the Office of the Fire Marshal and Emergency Management will be available at the conclusion of the courses, with the exception of the Awareness course and the Air Monitoring course, for students wishing to receive certification.

For the OFC NFPA 1072 Hazardous Materials Awareness exam the OFC, in conjunction with AS&E, will be offering provincial testing dates on a quarterly basis as described below.

OFC NFPA 1072 Hazardous Materials Awareness Online

This course will enable students to recognize the presence of hazardous materials, protect themselves, call for trained personnel, and secure the area. Students will be able to identify the name, UN/NA identification number, type of placard or other distinctive marking applied for the hazardous materials involved, collect information from the current edition of the *Emergency Response Guidebook (ERG)*, identify container shapes that can indicate the presence of hazardous materials, identify the basic information on safety data sheets (SDS) and shipping papers for hazardous materials. There is no restriction on the number of students per fire department that can register for this course. The online course availability is 30 days in duration, at which time students can complete the online course and final test at their own pace.

Online, self-directed through website

Students must commence the course on the start date and they have 30 days to complete the course or they will not be successful.

NFPA 1072 Hazardous Materials Air Monitoring for Emergency Responders

This 2-day air monitoring training will focus on chemical terminology and properties, their application to monitoring, sensor terminology, interpretation of readings provided by the monitor, and maintenance. Detection equipment covered will include 4-Gas, PID, PH paper, Colorimetric Tubes, and Radiation Detection Devices. This training will allow the students to better identify incident action options in a risk-based response. Students will be offered hands-on training with scenarios and chemical testing. For those planning to take Mission Specific or Technician courses, note that air monitoring is covered in those programs.

This course covers all the requirements of NFPA 1072 Chapter 6.7. Upon successful completion of this course students will receive an OFC record of completion certificate as proof of training.

Prerequisite:

NFPA 1072 HM Operations

Students are required to participate fully without restrictions in all work related duties.

NFPA 1072 Hazardous Materials Operations

The Hazardous Materials Operations course focuses on the recognition of a hazardous materials emergency, personnel safety, hazard assessment, and the notification of higher skilled emergency responders or technical response teams. Students will become familiar with the *Emergency Response Guidebook (ERG)* and learn about the mandate and authority of the Canadian Transport Emergency Centre (CANUTEC). Students will explore topics such as placards, containers, and materials involved; determine whether materials have been released, PPE, emergency decontamination, and the evaluation of the surrounding conditions. By collecting hazard and response information, students will develop a “risk-based response” plan.

Students must provide their own turnout gear. To maximize firefighter safety, students are required to bring their own SCBA and two air cylinders. Information and guidance on safely transporting SCBA and cylinders to and from the OFC are included in the pre-class information package for this course.

This 3-day course examines the role of the incident safety officer (ISO) at any situation requiring an emergency response and will define their operation within the incident command system. The student will be able to evaluate and prioritize risks while using critical thinking to analyze and mitigate hazards. Students will learn to select the most appropriate control measure to ensure the effectiveness of emergency response and enhance firefighter safety.

The program will cover the role of the safety officer including, safety, regulations and standards, and reading buildings, smoke, risk, hazardous energy, and firefighters. The course also examines triggers and traps, developing a systematic approach, and ISO responsibilities at structure fires, wildland fires, as well as technical and post-incident responsibilities. This training will allow the students to identify incident action options in a risk-based response. Supplemental scenario-based training will also allow students to apply what they have learned.

Provincial testing through AS&E with the Office of the Fire Marshal and Emergency Management will be conducted at the conclusion of the course. To receive certification, students must also complete and submit their skills sign-offs to AS&E.

Provincial Offences Act (POA) Part 1 Tickets and Entry Warrants

This 1-day POA Part 1 training session will be broken into two components: tickets and entry warrants. Students will develop a comprehensive understanding of how to commence a proceeding under Part 1 of the POA (tickets) to address identified fire safety issues as well as how to obtain and serve an entry warrant. This workshop will teach students to correctly complete and file a Certificate of Offence and prepare an effective entry warrant.

Strategies to enhance fire safety in buildings, including enforcement of applicable fire safety standards, directly affect the fire service. Recent changes have been made to increase the number of Part 1 Tickets with increased fines now available to support enforcement options and assist the fire service in addressing identified contraventions of the Ontario Fire Code. Additionally, more departments are utilizing entry warrants to obtain entry to premises for the purposes of conducting fire safety inspections.

Fire Dynamics – From Knowledge to Practice

The OFC is pleased to offer this comprehensive 5-day course incorporating scientifically validated materials and best practices from around the world. The curriculum teaches an understanding of fire dynamics alongside practical evolutions suitable for multiple jurisdictions. Changes in building construction, complexity, occupancy levels, and increased fuel loads have altered the modern fire environment, resulting in faster fire propagation, unanticipated events, and more rapidly occurring dynamic fire situations.

Through classroom discussions, case studies, and practical sessions, students will develop a clear understanding of fire dynamics concepts and fireground tactics. In addition to practical sessions on fire control, material covered will include fire and combustion theory, fire behaviour within enclosures, and the development and application of fireground assessment tools.

This course incorporates live fire training. It is an intensive and demanding 5-day course.

Industrial Firefighting

This 5-day course will provide Industrial Fire Brigades with the ability to conduct fireground operations for fires at industrial sites. This course adheres to NFPA 1081 Standard for Facility Fire Brigade Member Professional Qualifications, 2018 Edition and the NFPA 1001 Standard for Fire Fighter Professional Qualifications, 2013 Edition. It offers hands-on firefighting training including an introduction to incident management systems, PPE, SCBA, suppression techniques of Class A and B fires, search and rescue, forcible entry, master streams, firefighter survival techniques. Demonstration and practical evolutions through scenario-based training using smoke tower and burn building.

Prerequisite:

Restricted to firefighters employed by an Industrial, Commercial, or Governmental Fire Brigade.

Managing a High-Rise Emergency

This course familiarizes fire officers with the construction of high-rise buildings and the unique problems that the incident commander may encounter. The course is designed to give the fireground commanding officer the tools required to manage a high-rise emergency. The emergency can be as simple as a check-call or as complicated as a working fire on any floor. The course is specific to high-rise buildings and emergency response to one of these unique structures.

Solar Photovoltaic Systems, Wind Turbines, & Firefighter Safety

This course provides a general overview of current solar technology, with an emphasis on potential dangers to firefighters. Section 21 Guidance Note #6-34 Solar Photovoltaic (PV) Systems and Guidance Note #6-35 Wind Turbines require fire departments to develop operational guidelines to safeguard personnel from solar and wind generated electrical hazards; information provided in this course will assist with the requirements. This course will familiarize students with solar energy and wind turbine components and systems, as well as offer practical tactics to ensure firefighter safety.

A photovoltaic prop has been built for demonstrations and hands-on exercises at the OFC.

Students will review the Canadian National Emergency Response Plan and participate in a tabletop exercise using the plan and their newly acquired knowledge of railroad emergency response management.

Flammable Liquids Firefighting – Flammable Liquids by Rail

This course, offered in partnership with Canadian Pacific Railway is intended for firefighters who are employed in communities with railways or trucks that transport flammable liquids. The course will build upon students' knowledge of chemical response and industrial firefighting. Students will learn about the different Class 3 flammable liquids currently shipped in North America in large volumes, firefighting tactics with tank cars and trucks, and health issues related to these Flammable Liquids. Students will also learn how to effectively use AR – AFFF, cool vessels, and set up for large rail events.

Students must provide their own turnout gear. To maximize firefighter safety, students are required to bring their own SCBA and two air cylinders. Information and guidance on safely transporting SCBA and cylinders to and from the OFC are included in the pre-class information package for this course.

Prerequisite:

OFC NFPA 1072 Hazardous Materials Awareness

This course is intended for firefighters who are employed in fire departments in communities with class one railways that are likely to be involved in rail incidents.

Office of the Fire Marshal and Emergency Management Overview

Who We Are

The Office of the Fire Marshal and Emergency Management (OFMEM) is a branch of the Ministry of the Solicitor General.

Mission

The mission of the OFMEM is to contribute to an environment for the residents of Ontario that is safe from fire and other public safety hazards by providing leadership and expertise in the reduction and elimination of these hazards.

Role

The role of the OFMEM is to minimize the loss of life and property from fire in Ontario by providing:

- Support to municipalities and fire departments across Ontario in meeting the needs of their communities, including public education, fire prevention, firefighting, fire protection, training, and fire investigation
- Leadership within the Ontario Government by advising on standards and legislation relating to fire prevention and protection
- Recommendations for the provision of adequate levels of fire safety for buildings and premises within Ontario

Organizational Structure

The Fire Marshal of Ontario is appointed by the Lieutenant Governor in Council. The Fire Marshal acts as the principal advisor to Government on public fire protection policy and fire safety issues. In addition to administering the overall operation of the OFMEM and fire-related legislation, the Fire Marshal provides leadership to municipalities and municipal fire services in matters relating to public fire safety.

The OFMEM operates from a head office, in Toronto, as well as from offices in Midhurst, Sudbury, Thunder Bay, and the OFC in Gravenhurst.

The OFC

In operation since 1949, the OFC's primary mandate is to meet the education and training needs of the Ontario fire service. As of April 2014, the OFC offers education and training programs based mostly on the National Fire Protection Association – Professional Qualifications Standards.

OFC Advisory Committees

The OFC holds regular meetings with its Program Advisory Committees. All of the committees provide ongoing advice and recommendations to the OFC on all aspects of its programs and courses.
